What are Cookies?

A cookie is a small file of letters and numbers that is downloaded on to your computer when you visit a website. Cookies are used by most websites and do not harm your system. They can do a number of things, such as, remembering your preferences and personal information so you don't have to provide it again.

Cookie types

Necessary/ Essential cookies are absolutely essential for the website to function properly. These cookies ensure basic functionalities and security features of the website, anonymously. Necessary cookies are dropped onto your device when you open the webpage, and do not require consent.

Analytics/Performance cookies are used to understand how visitors interact with the website. These cookies help provide information on metrics such as the number of visitors, bounce rate, traffic source.

Advertising/marketing cookies are cookies that are placed on a user's device by websites or third-party advertisers, and are used to display targeted ads by building a profile of your interests. These cookies also track the effectiveness of marketing and online advertising campaigns.

Functionality cookies are small pieces of data stored on a web browser that help a website function properly by remembering user preferences, language, region, etc. These cookies do not collect or store any personal information.

Other uncategorized cookies are those that are being analysed and have not been classified into a category as yet.
